KEYNOTE: THE ROLE OF WEARABLE TECHNOLOGY IN PODIATRIC MEDICINE AND SURGERY

Bijan Najafi, PhD, MSc

Preventing foot disease requires the patient to have a central active role in self-managing their health. This is a shift from current practice, in which the patient is frequently a passive recipient of care. Thanks to advances in wearable and sensing technologies, ubiquity of access to the internet, and significant strides in machine learning and artificial intelligence, new emerging solutions have been developed to improve health care delivery, patient satisfaction, and population health across different disciplines while reducing the cost of care - in particular, recent "remote patient monitoring" technology. Although still new, this is becoming a frequent subject in the national health care conversation. For a patient, the benefits of remote monitoring are tremendous. The ability to track the key health information of an at-risk patient, either recovering from surgery or in need of chronic care, defines a shift in personalized health care. Providers will be able to essentially "be there" with the patient and support his/her caregivers when they cannot be in the home. There are currently several revenue opportunities for remote patient monitoring and services, which could also accelerate incorporation of these technologies for foot disease management in a near future. This talk will discuss some of recent technology developments relevant to foot disease management and their potential to be integrated into podiatry clinics to improve patient care and patient satisfaction.
